EU Regulation on Organic Farming gives priority to homeopathy

The EU Regulation 2018/848 on organic production establishes that phytotherapeutic and homeopathic products shall be used in preference to treatment with chemically synthesised allopathic veterinary medicinal products, including antibiotics, provided that their therapeutic effect is effective for the species of animal and for the condition for which the treatment is intended. President of Italian Federation of Medical Societies supports

homeopathy Dr Franco Vimercati, President of the Italian Federation of Medical Societies (FISM), stated, during the last FISM general assembly, that homeopathy is a medical therapy, which is regulated by an agreement between the Italian national government and the regions. Dr Vimercati also underlined that homeopathic medicines are regulated by a European directive.

Spanish Medical Council considers ethical the medical prescription of homeopathy

The Spanish Medical Council, in a reply to a sceptics' association, has stated that the prescription by medical doctors of therapies not scientifically validated is ethical. Several requirements need to be fulfilled such as safety of the therapies, their use as complementary medicine and information and consent of the patient. President of Romanian ECH association speaks to the press



Dr Ileana Rindasu, President of Romanian Society of Homeopathy has given an interview to the magazine România liberă. Dr Rindasu highlights that in Romania homeopathy is only practised by medical doctors with an additional qualification in homeopathy. To obtain this qualification medical doctors must enrol in a 2 years postgraduate training organized by the Ministry of Health

Hungarian Secretary of State defends homeopathy

Mr Bence Rétvári, Hungarian Secretary of State of Human Resources and responsible for relations with the Parliament, stated, in response to a parliamentary question, that homeopathy is practiced and used worldwide. Mr Rétvári added that it is the responsibility of the individual physician to decide whether she/he prescribes homeopathy to a patient. He also mentioned that the practice of homeopathy is subject to university examinations, state licensing and membership of the Medical Council.
