EUROCAM welcomes the recent adoption by the European Parliament of its report "Strengthening Europe in the fight against cancer - towards a comprehensive and coordinated strategy", which calls on the European Commission to set some key priorities in the implementation of its Europe's Beating Cancer Plan, with strong actions on cancer prevention strategies and equal access to highest quality cancer care.

The adoption of the report emphasizes the real need for Integrative Medicine to be included in the implementation of Europe's Beating Cancer Plan. It is very encouraging to see that Integrative Medicine has been taken up by the European Parliament. We hope that this will turn into strong actions that support high quality

research and good regulation aiming at the effective integration of complementary therapies in cancer care so that they become more widely available for cancer patients in all European countries. Our position paper outlines suggestions to the implementation.

The position paper concludes how the incorporation of evidence-based practices into mainstream care provides a coherent treatment approach as well as an ethical response to frequent requests and unmet needs from patients.

In Europe almost 40% of cancer patients choose complementary modalities as part of their treatment. Integrative Medicine therapies help improve Quality of Life and relieve disease burden and side effects of conventional treatments. The approaches by complementary therapies help improve outcomes through lifestyle management and optimization of treatment with the involvement of multidisciplinary healthcare workers. To ensure best outcomes and safety. educational continuous professional programmes and development should be mainstreamed.



EUROCAM therefore urges Integrative Oncology to be included in policies addressing any stages of cancer care, from prevention, to treatment, rehabilitation, follow-up, and palliative care, with special attention to paediatric cancer.

In 1839, the Hahnemann's were visited in Paris by an American actress, Anna Cora Mowatt. This is taken from her account of the visit, published under her pen name, Helen Berkley:

Hahnemann was reclining in a comfortable armchair, on one side of the table. His slender and diminutive form was enveloped in a flowered dressing gown of rich materials, and too comfortable in its appearance to be other than Parisian make. The crown of his large, beautifully-proportioned head was covered by a skull-cap of black velvet. From beneath it strayed a few thin snowy locks, which clustered about his noble forehead, and spoke of the advanced age which the lingering freshness of his florid complexion seemed to deny. His eyes were dark, deep-set, glittering and full of animation.
